SECTION 7 HEALTH HAZARDS AND FIRST AID

Effects of Overexposure:

SKIN: Skin irritant. Will cause defatting of skin. Effects are reversible. EYES: Eye irritant. Will cause redness and burning sensation. INHALATION: Effects of overexposure include irritation of respiratory tract, headache, dizziness, nausea, and loss of coordination. Extreme overexposure may result in unconsciousness and possibly death. INGESTION: Aspiration hazard if swallowed.
